1. Call to Order

Chairperson called the meeting to order at 7:39 pm

1. Approval of Minutes

Minutes were read from March 4th meeting. Stacie adopted minutes as read and Sarah seconded.

1. Principal Report - Angie Boyes (not present but gone over)

- Mrs. Richelle Smigelski will return from her maternity leave on April 29th, 2019. Her teaching assignment will include grade 8-9 flex period, grade 5 LA, grade 4A science and grade 4A LA centers.
 - Discussion had around current Grade 4 students and the need for parents to advocate for more consistency for them as they have been shuffled around so much. This advocacy needs to begin now for their Grade 5 year.
- The PRRD School Board passed a motion last week to have Oyen community grade 9 students attend SCHS effective September. Farewall will be June 7th and include both grade 8 and 9 this year.
- Fundraising- hanging baskets should be in May 23rd. Junior high students raised \$2500 in popcorn sales last week!
 - Can we have another show case made of fundraisers done and where the money has gone to show parents and community how important these fundraising events have been?

REAL REPORT – Amanda Yake-Kovitch

- The mentoring program is off and running! There are 128 students registered and 59 matches made and will run until the middle of May Tuesday and Thursdays at lunch.
